

## 9th ANNUAL HILTON YOUTH WRESTLING TOURNAMENT

- DATE:** Sunday, March 1, 2009. **Qualifier for Gene Mills Eastern National Tournament.**
- PLACE:** Hilton Central High School, 400 East Avenue, Hilton, NY 14468
- ENTRY FEE:** **\$15.00** per wrestler. Make checks payable to "HILTON YOUTH WRESTLING, INC."
- PRE-REGISTRATION:** All wrestlers must pre-register **before noon** on **Friday, February 27, 2009**. To pre-register, a wrestler must submit his/her **name, weight** (in wrestling gear and shoes) and **age** (as of 03/01/09): (1) by **mail** (Hilton Youth Wrestling, Inc.; PO Box 84, Hilton, New York, 14468); or (2) by **telephone message** (Dawn Brock 585-392-3906).
- A.A.U.** **This event is sanctioned by the Amateur Athletic Union of the U.S., Inc. All wrestlers must have a current A.A.U. membership. This A.A.U. membership is not included as part of the entry fee to this event. A.A.U. membership must be obtained before the competition begins. To obtain an A.A.U. membership, visit the A.A.U. web site [www.aausports.org](http://www.aausports.org).**
- WEIGH-INS:** **7:30 - 9:00 a.m.** All wrestlers will be weighed in wrestling gear and shoes. Brackets will be prepared using the weight submitted during the pre-registration process. If a wrestler weighs more than **two pounds** over the pre-registration weight, the wrestler may be disqualified from the tournament. **No walk-ins.**
- WGT. DIVISIONS:** **5 lbs. or 10% of body weight**, whichever is greater. Tournament officials may combine or change weight classes to maximize wrestling.
- AGE DIVISIONS:** **(5 - 6) (7 - 8) (9 - 10) (11 - 12) (13 - 14) No varsity experience.** Proof of age may be required if challenged.
- FORMAT:** 8 man brackets, double elimination, NYS high school rules, 3 one-minute periods for ages 5-12, 3 one-and-one-half-minute periods and **full mats** for ages 13-14, (one minute overtime if needed - sudden victory - first point wins). **Wrestling will begin at 9:30 a.m.**  
During the tournament, only coaches will be permitted at mat-side.
- AWARDS:** Trophies for top four places, medals for all non-placers.
- ADMISSION:** Over age 12 - \$1.00. Families - \$3.00. Age 12 & under - free.
- FOOD:** Available in the cafeteria. No food or drink in the gym. **No smoking on school premises!**
