Event Philosophy:

The event that everyone wants to see is back! The best of the best from neighboring states squaring off in a preseason round-robin format. Last year, our third year, was perhaps our best event ever. We had competitors from 24 different states. This year, 200 athletes will battle it out in their respective weight classes.

Tier 1 – Best of the Best

This is a true battleground for wrestlers on the east coast. Four-, six-, or eight-man round-robin brackets with all decorated and accomplished opponents (three to four matches for each wrestler) National, State or New England place finishers, followed by state qualifiers, get preference.

Tier 2 – Best of the Rest: the next four or five best-accomplished wrestlers.

Again, four- or five-man round-robin brackets with decorated opponents.

PLEASE DO NOT email or call asking for a particular tier. It doesn't work that way. A coaches' committee from around the country ranks the wrestlers, which in return, determines the tiers

FLO MAJOR - This event is one of the select few FLO Majors in the country and it's the very first FLO Major of the season. However, NOT all winners will be crowned FLO Major winners. Since there are two tiers in the event, only the weight classes deemed the 15 most competitive will get the nod, regardless of the tier. The 15 weights declared Flo Majors will be determined after weigh ins.

How do I participate?

If you'd like to participate in this event – please reach out to Journeymen Wrestling to research availability by emailing Frank@journeymenwrestling.com. This event is a small, ultra-competitive event and it will fill up quickly.

Rules:

- No postgraduates • NFHS Rules • Folkstyle
- Athletes cannot wear their high school singlets at the competition
- Bout Length: 2:00, 1:30, 1:30 periods • College out of bounds in effect

Tentative Weights: 99, 106, 113, 120, 125, 130, 135, 140, 145, 152, 160, 170, 182, 195, 225 and 285.

If certain weights do not get completely filled, we will match athletes up that are closest in weight (within reason). **Once you've been accepted at a particular weight, you are expected to compete at that weight since these are all pre-determined brackets. Therefore, select the appropriate weight from the start!**

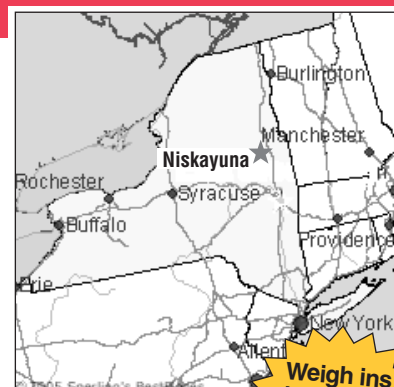

RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from any Journeymen Athletics, LLC sanctioned event, meet, practice or activity, including the risk of PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used. 3. Releasor acknowledges and fully understands that each participant in any Journeymen Athletics, LLC sanction event, meet practice or activity, including Releasor, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses to person or property, including death, and that severe social and economic losses may result not only from Releasor’s own actions, inactions or negligence, but also from the actions, inactions or negligence of others notwithstanding the rules of play or the condition of the premises or of any equipment used. Further, Releasor acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at this time.
