# Mysnyk Sec. 4's only champ

UTICA — Once again Section 4 wrestlers' showing in the state meet was sub-par if the late 1960s is any criteria as only Vestal's Mark Mysnyk in the 98 pound class brought back a state crown.

The only other Section 4 grappler to make a showing in the finals was Frank Borelli of Union-Endicott in the 250 pound class. He was defeated by Jim Duggan of Glens Falls after holding a 4-1 lead at one point.

Mysnyk got an early take-down on George Medina of Baldwinsville (Sec. 3), and rolled to a 10-1 victory.

Ken Doi of Sidney and Tim Jenks of Chenango Forks were beaten in first round action Friday night and both were expected to at least reach the semifinals in the state meet.

Section Three, which includes the Syracuse area, tallied 96½ points and outdistanced Long Island powers Section 11 and Section 8 which includes Nass

and Suffolk Counties. Others scores were, Section 11-90, Section 8-75, Section 5-66, Section 2-51½, Section 6-37, Section 1-33½, Section 4-30, Section 9-23½, Section 10-17, and Section 7-2.

Doi's showing was not as bad as it looks on paper as he suffered torn ligaments in his Friday night bout and had to forfeit in his wrestle-back Saturday. He was eligible to get the title via the back door because he lost to a finalist. Friday he lost, 4-3, to the eventual 105 pound champ from Canandaigua, Ron Langdon.

Ironically Doi had beaten Langdon earlier in the year in the Windsor Christmas tournament. Section Three also came up with the Outstanding Wrestler of the meet in Greg Stevens, 177 pound champ from Fulton High School.

Ken Davis, who reported this weekend's wrestling to the Star, said the crowd for Saturday's finals was estimated at 5,500

fans and he also said approximately 10,500 people watched the state meet Friday and Saturday.

The crown by Mysnyk was the first by a Section 4 wrestler in two years. The only other Section 4 entrant to place was North High sophomore Kurt Kaminsky, wrestling at 119. He was pinned by Rich Lubell of Bellmore Kennedy in the consolation bracket.
