



Mitchell, Bowers defend Class B titles

GENESE0—Ed Mitchell of Lyons and Guy Bowers of South Seneca, defending sectional champions, won individual titles at the Section 5 Class B wrestling tournament Saturday.

Mitchell defended his title at 177 pounds and Bowers, champion last year at 91, won the 98-pound championship.

Geneseo, the host school, took the team title. Marion was third and Lyons fifth.

Marion's Mike Compton defended his heavyweight championship, pin-

ning Lyons' Pat Maddock in the finals. The Black Knights Jeff DeRidder (105) and Al Pulcini (112), champions last year, were runners-up Saturday.

Dale Updike of South Seneca finished second at 132 pounds. The Falcons finished eighth in the team scoring.

Red Creek, the 11th place team, was led by Frank Heffernan's second place finish at 119 pounds.

The finalists as well as the third-place finishers in each weight class advance to the intersectional qualifier

this weekend.

Third-place winners include Mike Mitchell (91) and Greg Chadwick (105) of Lyons, Bob Newby (98) of Marion, Steve VanHeusen (138) of Dundee and Joe Condon (250) of Bloomfield.
