Schedule: Day 1 – Weigh-ins 10AM-11:30AM, Wrestling begins at 12PM.  
Day 2 – Weigh-ins 7AM-8:30AM, Wrestling begins at 9:00AM.

Day 1: Based on 2015-2016 ranking/results, returning wrestlers, and current season results the top four (4) teams will be seeded and separated into four (4) pools. The remaining 12 teams will be randomly drawn into each pool. Each team will wrestle every team in your pool on **Day One**.

At the conclusion of the day each team will be ranked in their respective pool. The winner of each pool will advance into the championship four (4) man bracket to wrestle for the team title. All remaining teams will be placed in a bracket with teams of equal place from the other pools for two (2) additional matches.

**Day 1 Pool Advancement/Tie-Breaker Criteria is included in this packet on Page 2.**

Day 2: All brackets will be wrestled to completion.

## **2017 Union-Endicott Duals Pool Advancement/Tie-Breaker Criteria**

The following criteria will be followed to determine day 1 pool placement:

**\*\*NOTE: CRITERION THREE (3) THRU TWELVE (12) IS AN ACCUMULATION FOR ALL DUALS\*\***

1. The team who won the greater number of duals.
2. Tie in dual wins:
  - If two (2) teams are tied the team who won the head-to-head dual.
  - If three (3) teams are tied and a round-robin win/loss situation (A def B, B def C, C def A) move to criteria three (3). If the three (3)/way tie is broken in criteria 3-12 and two teams are still tied, return to criteria two (2) head-to-head.
3. The team who has been penalized the least number of team points for flagrant or un-sportsmanlike conduct.
4. The team who accumulated the greater number of team points.
5. The team who won the most individual matches.
6. The team who accumulated the greater number of team points for all falls, defaults, forfeits, or disqualifications.
7. The team who accumulated the greater number of team points for technical falls.
8. The team who accumulated the greater number of team points for major decisions.
9. The team who accumulated the greater number of points for decisions.
10. The team who accumulated the greater number of pins in the least time.
11. The team who accumulated the quickest pin in any match from any dual.
12. The team who accumulated the greatest total point differential for decisions.
13. If none of the above resolves the tie, teams will draw for placement.
