

Keshequa Has Two Section Five Wrestling Champions

David, wrestling in the 115 pound class, did a superb job. In the first round of wrestling David met Len Keris from Byron-Bergen, who had a record of 17.0 for the season. The boys wrestled to a 2-2 draw and the match went into over-time. Dave was in complete control during the overtime match, he earned a point for escape and was awarded 3 pins for a near-fall. The match ended with Coon the victor by a score of 4-0. In the second round (semi-finals) Dave wrestled Frank Borra from Odessa-Montour Falls. Dave had no trouble during the match and won it by a score of 3-1. In the third round (finals) Dave met a boy from Livingston League, Bruce Billings from Perry. This was billed a tough match for both boys because they have met twice before and each had defeated the other.

Dave could not be deprived of the championship. He did everything but pin Billings. In fact many of the fans felt he had. When the match was over, Dave had won by the score of 7-2.

Keshequa had an inspired wrestler in the 175-pound class. Many local coaches favored Dwight Cartwright to win, but the coaches in general favored Don Loper from Canisteo.

In the first round Dwight met Tom Ricketts from Fillmore. Tom was not a new opponent to Dwight. This match ended as all the others between these two boys. Dwight was the winner by a pin in 1:55 of the 1st period In the second round Dwight met Don Loper. Dwight had a fast take-down, and showed Loper some of his great strength. From this point to the end of the match Loper tried desperately to keep from being pinned. Only the end of the match saved him, because he was on his back when the buzzer sounded. The match score was 6-0. In the third round Dwight met John Loveless from Marion. Loveless carried an excellent record into the finals, but the Section V title was not to be his. In 5:20, Dwight held Loveless on his back and the match was over.

Your State Income Tax

(Second in a Series)

Easiest of all the New York state income tax forms to use is the Card Form IT-200. You may use this

1. You were a resident of New York state for the entire calendar

year 1969:

2. Your income in 1969 consisted only of wages; dividends or interest which totalled less than \$10,000 (including the income of your husband or wife);

3. Your income from dividends and interest did not exceed \$1,000;

4. You wish to claim the 10 per cent standard deduction, and

5. You did not pay any estimated tax for 1969.

If you claim an exclusion for "sick pay" which is included in your wage and tax statement (IT-2102), or if you received income subject to New York state tax but exempt from Federal tax, you may not use the Card Form.

If you are married and filed a joint 1969 Federal return, you are eligible to use Form IT-200 if you decide to file separate New York state returns.

If you meet the conditions (1-5) noted above, you should use the

Card Form. As a Card Form taxpayer, all you need do is fill in your name, your home address and the county in which you live, your Social Security number, appropriate income

and exemption figures from your Federal return, the statutory credit, and State tax withheld from New York State wage and tax statement r (IT-2192). Attach that statement, sign the card form and mail it to the New York District Tax Office serving the area where you live. The Tax Department will do the

If you owe tax of more than \$1,
