

Everyone MUST compete in their own age divison except those who exceed the Maximum Weight

Bantam Division: (Born in 2010 and after)

Weight Classes: 40, 44, 48, 52, 56, 60, 65, 73, 93 MAX

Midget Division: (Born 2008 & 2009)

Weight Classes: 50, 54, 58, 62, 66, 70, 75, 80, 85, 93, 105, 134 MAX

Junior Division: (Born 2006 & 2007)

Weight Classes: 58, 62, 66, 70, 74, 78, 82, 86, 91, 98, 108, 120, 140, 166 MAX

Intermediate Division: (Born 2004 & 2005)

Weight Classes: 75, 80, 85, 90, 95, 100, 105, 110, 115, 120, 128, 136, 150, 175, 220 MAX

Advanced Division: (Born 2002 & 2003)

Weight Classes: 93, 100, 105, 110, 115, 120, 125, 130, 135, 140, 145, 152, 160, 171, 189, 220, 285 MAX

Elite Division: (Born 2000 & 2001)

Weight Classes: 111, 118, 125, 130, 135, 140, 145, 152, 160, 171, 189, 220, 285 MAX

Open Division: (Born 1999 and before)

Weight Classes: 125, 135, 142, 150, 158, 167, 177, 190, 220, 295 MAX

LENGTH OF BOUTS: Double Elimination Tournament

Bantam - Midget - Junior 1-1-1

Intermediate - Advanced - Elite - Open 1 1/2 - 1 1/2 - 1/1/2

Overtime: 1 minute sudden death followed by 30 second rideout if necessary

<u>WRESTLING RULES:</u> NYSPHSAA Modified rules; NYS officials will be used. **EVERYONE** must have **PROOF OF AGE** if challenged, **INCLUDING** the **PERSON ISSUING** the challenge. **IMPORTANT:** Once you have qualified for the **REGIONAL TOURNAMENT** you **MAY NOT** enter another **DISTRICT TOURNAMENT**. **ANYONE WHO DOES WILL BE DISQUALIFIED FROM ADVANCING TO THE REGIONALS**. Any entrant who falsifies information on an application to enter a disrict or regional MAWA tournament will be subject to a one-year suspension from the program, effective immediately upon discovery.

AWARDS: Medals will be awarded to the top four place winners in each weight class.

UNIFORMS: One piece singlets or alternate two piece are REQUIRED. NO T-shirts and NO striped socks will be permitted.

SPECTATOR ADMISSION: Adults: \$3.00 & Students: \$2.00 each day.

The top FOUR place winners in the Regional Tournament advance to the Middle Atlantic Wrestling Association's Eastern National Championships on May 5 & 6 at the Wicomico Civic Center, Salisbury, MD including Open Division entries. There will be a \$15.00 advancement fee to be collected at the Regional Tournament conclusion. Fifth & sixth place winners are alternates.
