Robert Dixon and Jeron Rogers of Monroe upset second seeded Otis Reddington and Cliff Robinson of Madison to highlight the preliminary rounds of the 25th annual City of Rochester Interscholastic Wrestling Tournament last night at East High School.

Dixon won by a referee's decision in the 138 pound match and Rogers won by decision, 4-1, in the 167 pound match. Neither is seeded among the top four in their weight classes.

The 138 pound match was tied 4-4 at end of regulation time and 5-5 at the end of overtime. The referee and both judges voted for Dixon.

Rufus Fairwell of West upset Mike Lacagnina of East, also in the semifinals. Fairwell, last year's runnerup in the 113-pound class and seeded third this year, decisioned Lacagnina 4-3 in the 112-pound match. Lacagnina was seeded second.

The quarterfinal match produced one major upset. Unseeded Mike Luce of East, 3-6 this season scored a stunning come from behind win over Otis Tucker of West in a 119-

pound match.

Luce, behind by 7-2 in the first period and 10-4 in the second period scored the last seven points, in the third period.

He scored an escape and a take-down to make the score 10-8. With two minutes remaining, Luce got Tucker into a cradle and held him close to the mat for a minute. He couldn't pin his man but finally gained a near-pin with a few seconds left to score the victory. Tucker was the only boy seeded higher than fourth to be upset in the quarters.

In a 145-pound match Charles Walker of East gained a narrow 8-7 win over Willie McDonald of West. Both boys rallied repeatedly from deficits but a last period takedown proved decisive for Walker. The score was 0-0 at the end of the first period and 4-4 at the end of the second period. The match brought East fans to their feet on several occasions and no match caused as much as noise from the fans — at least in the quarter finals.

Madison, in spite of the semifinal upsets, placed six men

in the finals, to be held tonight at 7:30. But West, paced by Rufus Fairwell and Joe Johnson in the 119 pound class, also placed six men in the finals and leads 71-68 over Madison after the quarters and semifinals. Edison is third with 54 points and host East is fifth with 50. Jefferson is fourth with 51.
