Harvard Loses Twice to Penn State, Stella Of Tufts Beats Klein—Axford of Tech Defeats Adair

STATE COLLEGE, Penn, March 29 | feated Arlie Tomlinson, Oklahoma Aggles, de-(A. P.)-A crew of heavy-muscled youngsters from points West and South took good firm holds on the prime college wrestlers of the East tonight and all but swept them from the annual National Collegiate Association tournament.

Out of a field of over 90 agile youths, many of them from the leading colleges of the East, only two from New England remained in the running for championships in eight classes after 46 preliminary bouts that turned the spacious gym at Penn State into a whirling panorama of arms and legs and flying bodies during the hectic scrimmaging of the opening day. There were two more from the South, the remains of the Virginia Military Institute entry, while all the rest eame from points West-mostly Oklahoma.

Neck and Neck

Battling neck and neck for the team title, the grapplers of Oklahoma University and Oklahoma Aggies between them grabbed nine of the 32 places in the semifinals to be staged here to-The university morrow afternoon. had a slight edge on the Aggies, five to four, and are favored to win the crown the Southwest farmer boys are defending.

Three champions came through in successful defense of their titles, Joe Sepora of Illinois leading the way in the 115-pound class, while Lawrence Oklahoma University Mantooth of found ordinary opposition among the 126-pounders, and Earl McCready, unlimited class title-holder from the Oklahoma Aggies, scored a quick fall to win his only bout.

The East failed to win a single bout in 24 quarterfinal bouts tonight, but the scarcity of opposition in the 115 and 125-pound classes, staged this afternoon, gave Robert B. Axford of Massachusetts Institute of Technology a quick trip to the 115-pound semifinals, and Frank Stella of Tufts jumped into the same status with one 125-pound victory.

Illinois Has Four In

The University of Illinois qualified four men for the semifinals along with the Oklahoma Aggies, while Northwestern, Iowa State, Kansas State, the University of Michigan, and Virginia Military in the South counted two apiece.
