## Irondequoit in command with 8 wrestlers in semis

Coach Art Connorton thinks his Irondequoit wrestling team could end the year ranked No. 1 in the state. Yesterday, after the Indians' romped through the first segment of the two-day Monroe County League tournament at Rush-Henrietta Sperry, few could argue.

Irondequoit, currently ranked 13th in the New York State Sportswriters Association Poll, placed eight wrestlers in today's semifinals and opened a commanding 18-point lead over surprise runner-up Penfield, 94-76.

Meanwhile, defending county champion East Rochester also slipped eight athletes into the semis and, despite its misleading 2-2 dual meet record, loomed boldly in third place with 70 points.

The day's only major upset was a disappointing showing by unbeaten and much-heralded Brockport. The Blue Devils, 5-0 in dual meets and ranked 20th in the state, advanced only four wrestlers to the semis and currently stands eighth in the 18-team field.

Today's semifinals begin at 10 a.m. Finals are scheduled to begin at 8 p.m But by then, Ironde-

quoit may be long gone on its way to the team title.

"I've had teams that have killed other teams in tournaments," Connorton said. "But if you would have put them against a well-balanced team in dual meets, we'd have lost three or four a year.

"This year, it looks like we've got both."

Connorton has seen some pretty good wrestling teams in his 20 years at Irondequoit, but calls this group his best ever.

"The only kid on this team who wasn't All-County last year was (Dallhart) Payne," Connorton said. "And he made it today. When everyone you have is All-County, you can't have a bad team."

Connorton doesn't have a bad team. Awesome is more like it.

Start with defending county and Section 5 Class AAA 105-pound champion Tony Cotroneo. He finished fourth in the state meet at 105 last year, and will record his 100th varsity wrestling victory if he wins two matches to capture the county 112-pound title today. Cotroneo, a four-year varsity veteran as a junior, is 98-9 in his career and 10-0 this season to date.

His brother, eighth-grader Chris, is 7-0, but faces unbeaten Larry Kane of Penfield in today's 105-pound semifinals. Kane, the defending county and Sec. 5 Class AAA 98-pound champ and a third-place finisher in last year's state meet, heads unbeaten Penfield's (4-0) six-man assault into the semifinals.

"Last week we didn't have that many in the semifinals of our own tournament," said Penfield's Chris Kane, who lost a 4-3 decision at 119 pounds when Irondequoit's Tim Lehmann was awarded a two-point takedown in the final seconds.

Joining the Cotroneos and Lehmann in Irondequoit's semifinals lineup are Glen Locke (126), Bret Simpson (132), captain Jim Brault (138), Scott Simpson (155) and Dallhart Payne (177). Lehmann, Brault and Brett Simpson, who cracked the starting lineup when Preston Stahl came down with tonsillitis and pneumonia, all are undefeated.

PIN POINTS: The semis may well render the finals anticlimatic from a team scoring standpoint. Whereas individual victories in the quarterfinals are worth between five and seven team points, and victories in the finals worth from four to six, semifinal triumphs are worth 12 (a decision), 13 (a superior decision) and 14 (pin) points apiece

or decision) and 14 (pin) points apiece .. East Rochester would appear to have three solid shots to close ground on Irondequoit - defending county champion Mike Kuhn (126); defending county and Sec. 5 Class A 119-pound titlist Romeo Battazzi (132), the outstanding wrestler of last year's tournament, and improving Bill Condon (177) . . . It was one of those days for Brockport. Previously unbeaten Todd Buenting lost a 145-pound decision to Churchville-Chili's Scott Trainor, 6-1. Ralph Matsko was blown out by Rush-Henrietta Sperry's Tom Rosa at 155 pounds, 12-3. "We'll come out and do our best in the wrestlebacks (a second-chance for one-time losers to work back to as high as third place) and do the best we can, but it's pretty much over with teamwise," Coach Jeff Brown admitted . . . Previously unbeaten Rich Kase (155) of Pittsford Mendon dropped out after he suffered a broken rib in his preliminary match. He came back to wrestle in the quarterfinals, but withdrew.
