

# LEHIGH GRAPPLERS PREVAIL IN BOUTS

*Bethlehem Institution Leads Eastern Entries by Qualifying Four Contestants for Semi-finals of National Collegiate Championship Meet*

BETHLEHEM, Pa., March 24.—The field of 79 entries competing in the sixth annual National Collegiate Athletic Association championships at Lehigh University was whittled down to 24 survivors for the semi-finals tomorrow afternoon. The finals and place bouts will be held in the evening.

Utilizing two mats and presenting the bouts without any delay, 55 bouts, many of which required extra periods, were crowded into one day of wrestling. The preliminaries held in the afternoon were followed by the second-round bouts in the evening, the latter totaling 32 in number.

Lehigh University, host to the visiting collegians, was the most successful of the Eastern colleges. The Bethlehem collegians placed four men in the semi-finals in Milo Meixell, 118-pounds, and Captain Pete Peck, 166 pounds, both of whom won on falls, while Ben Bishop and Gus Kramer, the other two qualifiers, won their bouts on decisions. Bob Dalling, Lehigh's 126-pound intercollegiate champion, was eliminated.

Indiana University was another of the successful colleges in placing men in the semi-finals, tied with Lehigh with four up to the 175-pound class.

## **Dupree Wins Bout**

Gordon Dupree, of Oklahoma A. & M. started the 175-pound bouts with a fall victory over William Moulder, of Syracuse, to win in 3 minutes and 38 seconds. Dupree used a bar arm and chancery hold.

Wes Brown, of Northwestern S. F. E., of Oklahoma, who is a Big "10" champion and Olympic finalist, won a close decision over Richard Ames, of Harvard, with a time advantage of 1 minute and 44 seconds. Robert Hess, of Iowa State, defending champion and member of the Olympic team, won over Richard Voliva, of Indiana, on a referee's decision. The time advantage was 2 minutes.

In the remaining 175-pound bout, Arthur Sweet, of Southwestern S. T. C., of Oklahoma, won handily on a decision over Edward King, of Columbia. The time was 4 minutes and 40 seconds.

## **Brown Heavy Winner**

In the first heavyweight bout James Hay, of Brown, threw John Hordines, of Syracuse, in 4 minutes and 54 seconds, with a head and arm lock hold.

Frank Ambrose, of Lafayette College, surprised by throwing vo

Rinaldi, of Kent State, Ohio, with a body hold. The time was 6 minutes and 20 seconds.

Robert Jones, of Indiana, a Big "10" champion and Olympic finalist, upheld his record by earning a referee's decision over A. Sintic, of Ohio University, with a time advantage of 6 minutes.

The last bout of the evening found Ralph Teague, of Southwestern, a member of the Olympic team, winning over Ernest Zeller, of Indiana, with a bar nelson. The time was 6 minutes and 8 seconds.
