Topic: Section V Class B3 Wrestling Tournament

Date: Saturday February 8, 2020.

Lineup: You will be receiving an e-mail document from Jeff Howard that is to be filled out and returned to him. This is how your lineup for the Tournament is to be submitted. Please be sure to adhere to all deadlines, as this list will be the information used for seeding. This will allow the inputting of information prior to the seeding meeting and the tournament start. Once the seeding is completed, you will only be allowed to make scratches, there is no shifting of wrestlers from one weight class to another. Seeding: The seeding meeting will take place on Wednesday February 5, 2020 @ 6:00 PM in the restaurant @ Davis's Countryside Meadows in Pavilion NY. All Class B coaches are invited to attend. There is a seeding committee and they have been contacted.

It is critical that your seeding information is in the hands of one of the seeding committee members prior to the meeting. All The Division II classes will be meeting at the same location.

You may send your sheets with another class committee member if that is more convenient. The B3 Seeding Committee members are: Todd Taylor B-R CS, Greg Cook AA CS, Phil Leitten-Perry CS, Chip Day- C-M CS, and Mike Witkowski – Fillmore CS. All coaches are free to attend, however any questions/conflicts will be resolved by a vote of the seeding committee. You must use the seeding form provided to you by Bill Hadsell. You must attach the proper season record from the NWCA website to each entry. We will not be calling around for records and entries. There should be an entry form filled out for every weight class by every

school. If you do not have an entrant in a weight class, please fill out on entry form with no entry and include the weight class and school name.

Weigh-ins: Saturday weigh-ins will be 8:00 AM- 9:00 AM.

Admission: The charge for all sessions is \$5.00 per session. A \$10.00 wristband will be on sale that will be entry for both sessions. Please let your fans know that the wristbands will be available and that they will provide a savings over individual ticket purchases. There will be two sessions on Saturday; 1) Saturday-daytime, and 2) Saturday-finals. Your wrestlers, a scorekeeper, bus driver, and an assistant coach will be issued passes. All others will be expected to pay. Please inform your parents and fans so that they know the ticket policy/prices in advance.

Schedule: Wrestling will be conducted on four mats, two in the upper gym and two in the lower gym. We will attempt to stay as close to the following schedule as possible. If a round ends early then the next round may begin earlier than tentatively scheduled. We are planning few if any breaks except for the needs of the officials.

Refreshments: The Bolivar-Richburg Central School Varsity Wrestling Club will run the concessions. There are to be no glass containers of any kind in the locker room areas. There will be a full service cafeteria and a snack bar available. Fruit, pizza, subs, and beverages will be available in the Concession area. All food is to be consumed in the designated area.

Awards: Each weight class champion will receive a Section V shield. The team champions will be given a Section V trophy plus a shield for each team member. The six wrestlers who advance to the Section V State Qualifier will receive a t-shirt from the Section V Friends of Wrestling.

Supervision: B-R CS staff will provide supervision. All coaches and their assistants are asked to be visible in the gym, cafeteria, and locker room areas. This

will keep wandering and other problems to a minimum. There will be only **two**-I repeat- **two** persons in each corner. Scorekeepers are to be seated at the scorer's tables. Photographers are to be in the stands, not on the side of the mats.

Parking: **All buses** are asked to drop their students off in the front of the school and then to park in the designated area in the back of the school. This means all buses large and **small**. There may be staff to direct the drivers to the correct location. All passenger cars/trucks will be parked in the front lot. You are also asked to not arrive on Saturday prior to 7:30AM. Buses will unload team personnel, and will then be asked to move to the back of the school. After wrestling is concluded on Saturday, the buses will return to the front of the school to load for the trip home. Parking is limited, so please be considerate of our spectators and their need to have adequate parking.

Locker Rooms: There will be Locker rooms available for all wrestlers. We ask that all wrestlers keep any valuable items with them at all times. Clothing, uniforms, jackets etc. should not be left in the locker rooms. These rooms are meant to change/shower. Please store duffle bags in a common area under the bleachers where your team may keep an eye on them. The bleachers are not to be used to store duffle bags etc., as the seating is limited.

Table Help- Each school is going to be responsible to staff a scorer's table during the tournament. Below is a tentative schedule for the tournament. Gilead will be available to help/or complete an incomplete crew
