

# EFA Dethrones Southside Matmen; Waverly Third

Elmira Free Academy dethroned Elmira Southside as team champion in the Third Annual Elmira Invitational Wrestling Tournament held at Horseheads on Wednesday. EFA scored 103 team points to 95 for Southside.

Waverly finished third with 53 points and took two individual titles—Paul Barnes at 103 and Mike Doane at 154. The other teams placed as follows: Bath, 44; Horseheads, 35; Corning West, 30; Sayre, 20 and Elmira Heights, 12.

Waverly failed to enter a man in the 95 pound class. At 103, Paul Barnes pinned Westbrook of Elmira Heights, decisioned Vores of Horseheads 5-2 and in the finals, decisioned Otis Maxwell of EFA to give Waverly its first individual championship in the tournament.

At 154, Mike Doane pinned Woodburn of Sayre in 1:45 and then decisioned Biggio of Horseheads 8-2. In the finals, Doane decisioned Jackson of EFA 3-1 for the second individual victory for Waverly.

Jim McCloe wrestled at 112 and decisioned Roche of Bath 8-1 but dropped a 6-2 decision to French of Corning West. In the consolation round, McCloe decisioned Sandor of Sayre 4-1 to take third place.

At 120, Dave Hasco pinned Wheeler of Bath in 5:04; then was pinned by Moss of Elmira Free Academy in 5:22. Moss went on to win the 120 pound title. In the consolation round, Hasco pinned Howland of Horseheads in the third period for a third place.

Gary Kouterick, at 127, lost a close 8-7 decision to Murphy of Bath in the first round and was eliminated.

John Hoxsie wrestled for Waverly at 133 and finished second. Hoxsie pinned Calkins of Corning West in 3:07 and then handed Cook of Elmira Southside his first loss of the year by taking a 6-4 decision. In the finals, Hoxsie dropped a 3-1 decision to Mike Ried of EFA.

Waverly failed to enter a wrestler at 138. At 145, Stan Smith was paired against top-seeded Norris of Corning West, last year's defending champ. Smith dropped a 12-5 decision and was eliminated.

At 165, Don Wilson pinned Stanton of Corning West in 2:11. Wilson then dropped a 4-2 decision to Inmken of Bath and lost 4-3 to Carr of EFA to finish fourth.

At 180, Hal Bonning lost a 4-3 decision to Manchester of Elmira Southside and was eliminated. In the heavy weight division, Jim Spaulding was beaten 4-2 by Arman of Horseheads.

The Sayre grapplers did not fair

nearly as well as the Wolverines in the tourney. Sayre did not advance anyone to the finals and managed only 20 points for a seventh place finish.

Sayre's Robin Munn, 95 lb., won the consolation round with a 10-5 decision over Ferris of Corning West. Earlier, Munn lost to Rich Lucas of EFA on a referee's decision in the semi-finals.

Sayre's Campbell, 103 lb., was eliminated in the opening round as he was pinned by Swimelar of Southside.

At 112, George Sandor defeated Losito of EFA in the opening round. However, he lost to Kimble of Southside, 7-4, and later fell to Jim McCloe of Waverly in the consolation round.

Gary Munn of Sayre, 127 lb., fell to Davis of Southside, 9-6, in the first round.

At 133, Horton of Sayre was defeated by Keltz of Bath 5-0.

Mike Werkheiser, Sayre's entry at 138, decisioned Benedict of Edison, 12-2, but then lost to Seymour of Southside, 7-4, in the semi-finals.

Willie Johnson at 145 was pinned by Stratton of Southside in the first period of an opening round match.

At 154, Woodburn of Sayre was pinned by Mike Doane of Waverly.

At 165, Mingos of Sayre was pinned by Denny Middaugh of Southside, the tournament champ.

Sherman of EFA decisioned Greenwood of Sayre 8-3 in the opening round of the 180 lb. class.

In the unlimited class, Jerry Schaffer of Sayre was decisioned by Friedland of Bath.
