

Two More for Bomber Matmen; 4 - Team Matches Set Saturday

There's no energy crisis on the East Rochester High School wrestling team.

Coach Don Quinn's powerful Monroe County East Division leaders posted two more victories over the past weekend to run their record to 7-1 in dual meets and 6-0 in league action.

Showing their class before home galleries last Friday and Saturday nights, the locals tipped both rivals easily. Bishop Kearney, a City Catholic club that boasted a win over the only team to top ER this season, McQuaid, was whittled, 35-6 in a non-loop affair, while Pittsford Sutherland fell victim to a record ER score, 61-0.

In the 24 matches on the two-night card, the Bombers lost only the 100-pound opener in the Bishop Kearney tilts when Marl Morabito dropped a 4-point superior decision to Tony Germano. The other mar on the ER performance was a 2-2 draw waged in the 121-pound match between Bomber Don Patrick Quinn and Joe Berardi.

At the end of the tussle, the score read 7-7.

Quinn's club amassed its points on Ted Hagberg's 9-2 decision 107-pound scrap over Dave Watro. Chris

Bourne put aside. Ernie Hanna by a 8-2 tally in the 114-pound scrap, and Ron Ricotta punished Larry Phillips for a default 6-point verdict when his rival couldn't shake off an arm injury in the 128-pound show.

Bob Steinruck scored a point with 14 seconds to go of his 6 minute scrap with Rick Watro and it was good for a 1-0 nod in the 134-class.

Skip Farchione at 140 increased ER's lead to 20-6 as he outclassed Bob Spinelli, and Brian Chaney put 3 more points on the ER scorecard with a 8-6 decision over John Chinnic in the 147-pound clash.

Tim Duffy at 157 was a 4-0 winner over Mike Tiano; and ER's lone undefeated wrestler, Richie McPhee at 179, added George Medling to his list of victims by bagging a 8-2 verdict.

In the heavyweight class, Quinn got a neat surprise from Don Verni as the big fellow trailed 2-0 at the end of the first 2 minutes and then outscored Mark Nicolini, 3-2, in the second to make that margin hold up through the last period.

Sutherland failed to garner a single win in its lopsided loss to the locals. Morabito nabbed his second win of the season in the lid lifter, a pin in 3:43 over Ross Richards, and Hagberg posted a forfeit.

Bourne disposed of Rick Welch, 10-2, and Quinn tallied the same winning score against Pete Fitzsinger.

Joe Aloisio at 126 ran away from Scott Hansen for a superior nod, 17-2; and Ricotta was threatened by Steve Held before winning, 3-2. Steinruck pinned Steve Comstock in 5:15 and Farchione took 2:11 to seal down Chuck Pugliese.

The pin fever continued as Chaney flattened Pat Tanner in 3:11; Duffy just had to show on the mat to net a forfeit, and McPhee took

Lisi in 3:30.

It may have been the feature match when lighter Dan Goodman stacked up against bigger and taller Pete Navratil of the visitors and after a scoreless first period, Goodman, son of shoemaker "Crash" Goodman; stitched his opponent to the canvas at the 2:33 mark.

ER hosts a four team afternoon and night mat extravangaza on Saturday. The mat card lists Jayvee and varsity action involving besides East Rochester, another East Division member, Fairport; and two city schools, East High and Edison.

Starting at noon, on the twin mats, Bomber coach Sam Morabito's JV's stack up against Edison while Fairport is angry with East. And at 1:30, ER tussles with East while Fairport is clashing with Edison.

In the main bouts starting at 6:30; first matches on both mats list the Bombers testing a good rated Edison High varsity and Fairport tugging it out with East. When 8 o'clock rolls around, the matches list Fairport against Edison while the Bombers will be in an
