SPORTS UPDATE The Livingston-Wyoming County Wrestling Tournament was held Saturday, Pebruary 14, at Caledonia-Mumford Central School. Standings by team, after the quarter-finals, included LeRoy in first place with 133 points, and Geneseo in second with 120 points. The next teams in order were Avon, 78% points; Letchworth, 78; York, 77. Caledonia-Mumford, Wayland, Keshéqua, Livonia, Dansville, Warsaw, Perry, Mt. Morris, and Honeoye Falls-Lima completed the field. Perry and Warsaw were tied for eleventh, while HF-L and Mt. Morris were tied for thirteenth.

Action after the opening round is summarized in this article.

At 91 pounds, Jeff Royce of Warsaw pinned Jim Barrett of HF-L in 0:35. Jeff LaBell of Wayland pinned Mark Mosman of York at 3:48, and Gary Dempsey of LeRoy decisioned Brett Hill of Avon, 5-2. John Young of Livonia decisioned Jim Sullivan of Keshequa, 12-9.

In semifinal action at 91 pounds, Jeff Rovce. Wapsew; pinned Jeff LaBell, Wayland. at 5:15. Garv Dempsev of LeRoy, pinned John Young of Livonia at 5:15. John Young pinned Jeff LaBell in the consolation, for third place, in 5:32.

Dale Matoon of Perry, in the 98-pound weight class, pinned Kevin Sampson of Letchworth at 5:10. Vince Lang of Dansville pinned Steve Cuozzo, York, at 1:59. Mike Blue, Keshequa, decisioned Bill Grayson of LeRoy, 9-4. Mike Cook of Geneseo decisioned Mike Smith of Mt. Morr18 9-2.

Advancing to the semifinals, Dale Matoom, Perry, decisioned Vince Lang, Dansville, 7-4. Mike Blue of Keshequa, in the other bracket, pinned Mike Cook, Geneseo, at 4:37. Mike Cook won the third place consolation by decision over Vince Lang, 5-2.

Quarterfinal action in 105-pound class saw Letchworth's Dan Sacco decision (superior) Keshequa's John VanDorn, 15-1. Mark Love, Geneseo, decisioned Avon's Chuck Dauphine, 4-2. Steve Brown of Wayland. in the other bracket, pinned Kurt La Wall of Warsaw in 0:15. Steve Fuller, LeRoy, pinned Tom Alverson, Dansville, in 1:43. In the semifinals, Dan Sacco, Letchworth, decisioned Mark Love of Geneseo. LeRoy's Steve Fuller pinned Wayland's Steve Brown at 2:40. Brown came back to win third place with a decision over Mark Love, 7-4. In the 112-pound class, Lyle Turybury, York, opened the quarterfinal round with a superior decision over Kelly Smith of Mt. Morris, 19-0. Mike Kelly of Wayland, decisioned Stacy Phillips, Avon, 4-0. Warsaw's Dan Tucker pinned Bill Donovan, Keshequa, at 1:13. Tony Vallance of Letchworth, pinned Tim Davis of Caledonia-Mumford at 2:50. Moving into semifinal action, York's Lyle Turybury decisioned Mike Kelly, Wayland, 8-4. Also, Tony Vallance won a decision over Dan Tucker, 4-2, after a 2-2 score that stood at the end of the second period. Mike Ke-11v of Wayland won the consolation match, 7-4 over Dan Tucker, Warsaw. The first quarterfinal match at 122 pounds was won by York's Van Schirmer, who superior decisioned Perry's Charles Miess, 25-4. Jeff MacDonald, Cal-Mum, pinned Geneseo's Terry Hotchkiss at 5:45. Mike Corcimiglia, Le-Roy, decisioned Roger Morsch, Dansville, 13-5. Tom Costello, Wayland, pinned Warsaw's Geof

Hendrickson, in 129-pound semifinal action, pinned Oklevitch, time unavailable. Le-Roy's Mowry pinned Dansville's Duffy at 1:53. Oklevitch pinned Duffy at 1:55 to win the consolation round.

Dana Richard, Geneseo's 135pounder, won a superior decision over Letchworth's Cal Sampson, 16-0. Livonia's Tim Allerton won the next quarterfinal match by pinning Dansville's Bruce Merle at 3:02. Tony Perry, Mt. Morris, won a superior decision over York's Randy Burdick, 15-2. Andy Vonglis, Avon, pinned Wayland's Terry Fairbrother at 3:51.

In semifinal activity, Geneseo's Richard pinned Livonia's Allerton at 3:56. Mt. Morris's Tony Perry wrestled Avon's Vonglis in the other bracket. Vonglis moved into a 2-0 lead, but Perry tied the match at 2-2. Vonglis led 7-2 following a reversal at the start of the third period, and eventually won, 10-2. Livonia's Allerton defeated Perry 4-1 for third place, in the consolation match.

Chris Gerlach of LeRoy opened quarterfinal action at 141 pounds with a 14-2 superior decision over Dansville's C. C. Comer. Jack Minteer, Livonia, decisioned HF-L's Chad Hoh, 8-3. Letchworth's Jim Shearing edged Avon's Jim Vonglis, 2-0, and Sean Loughlin of Geneseo decisioned York's Matt Luckenbach, 10-4.

Chris Gerlach and Jack Minteer then wrestled a match that was scoreless until Minteer scored a point with 30 seconds left in the third period. Minteer added two points with a takedown with 5 seconds left, and two points at the buzzer for a 5-0 victory. In the other semifinal match, Geneseo's Loughlin decisioned Letchworth's Shearing, 8-4. Shearing then wrestled LeRoy's Gerlach, led 7-2 after the second period, and won 15-4. In the 148-pound class, Rusty Korth, York, decisioned Warsaw's Mike Royce, 9-2 in quarterfinal action. Dan Pagan, Avon, edged Dan Pangrazio, LeRoy, 5-4. Barney Smith, Livonia, pinned Tom Strain, Keshequa, in 5:29. Rob DiFranco of Geneseo pinned Cal-Mum's Bob Downey at 3:53. Avon's Fagan, in a semifinal match, decisioned York's Korth, 10-1. Geneseo's DiFranco pinned Livonia's Smith at 3:30. Barney Smith defeated Busty Korth 7-2 in the consolation for third place. Jim Farrell, Geneseo, in 158pound quarterfinal action, pinned Wayland's John McCallum at 3:10. John Barber of Letchworth pinned John Gustavson, Keshequa, at 5:30. Steve Button of Perry pinned Paul Douglass, York at 3:57. Dave Ianiro of Cal-Mum won a superior decision over Jeff Chester, LeRoy, 13-1. Car-Mum's Ianiro then wrestled Perry's Button, and led by 791 and 9-2 before winning 15-4. ## Electric Bills I

The protest against the recent high electric bills mailed to some 600 customers served by Rochester Gas & Electric has resulted in nearly 200 signatures on a petition to the New York State Public Service Commission.

The petition drive organized by Pike resident Carol Fetrin is a move, according to Mrs. Ferrin, to let the state regulatory agency, R.G.&E. and local political representatives know that the people can not afford to bear the cost of ever increasing utility bills.

This newspaper contacted Anthony Vasile, Genesee District Manager for Rochester Gas and Electric to learn the reasons for the recent rate jump.

Mr. Vasile reported that three factors were responsible for the increases in the bills. The first component, according to Vasile, was the length of the billing period. The district manager stated that the period was longer due to the holiday season, Christmas and New Years.

Secondly, Mr. Vasile said that the billing period was 100 percent colder than the previous year, thus increased electric was used to operate furnace blowers and fans. He also remarked that with the holidays, more baking and cooking is done along with extra Christmas lighting which accounts for some families electrical usage increase. The fact that children are home from school for holiday vacation, Mr. Vasile said, results in more electric use with TVs on longer and stereo and radios used for longer than normal time periods.

Thirdly, Mr. Vasile said that during the billing period, the utilities Ginna nuclear plant was off line due to government mandated inspection regulations. The output
