Wins Six Individual Titles On Way To Rockland Wrestling Championship

Nanuet, N. Y. - Seven of the 12 champions crowned Saturday night in the Rockland County P. S. A. L. wrestling tournament were repeaters, although not necessarily in the

DUSANENKO HONORED

The thirteenth champion was Suffern, which won the team laurels with 161 points. Far behind with 95 tallies was Clarkstown.

Jerry Dusanenko of the Rams was named as the outstanding individual performer. After drawing a bye in the preliminary round, he won three straight matches on pins. pounder, one of the repeaters, stopped Bill Hoffman of Nanuet in 2:23. When they met in the semifinal round last year Dusanenko won by a 4-3 decision.

Suffern won six individual crowns. Don Ward repeated at 115 when he decisioned Mel Cooper of Nyack, 7-3. Jack Canvictor last year at 106, stepped up to the 123-pound class and pinned Pete Brennan, teammate, in 5:42.

Another bout involving two Suffern boys came in the 130pound class. Lou Salzman, last year's 123-pound champ, routed Dick Johnston by a 10-1 score.

Bill Kruckmeyer, who like Salzman moved up one class, gave the Mounties their fourth straight champion when turned back Al Askew of Nyack, 3-0. Terry Polevoy made it five in a row by edging Tom Human of Haverstraw at 141 pounds.

Howie Peirano was the final victor for the Mounties when he eked out a 4-3 verdict against Bill Hampton of Clarkstown at

157 pounds.

RAMS TRIUMPH

Clarkstown had two other winners beside Dusanenko, Vic Del Regno opened the round with a 4-3 win against Eric Watts of Suffern at 98 pounds. Bob Knapp trounced Rod Clune of Spring Valley, 13-5, in the 168pound match. Knapp won the honors last year at 157 pounds.

Russell Roefs of Spring Valley did the expected when he won the heavyweight match. In doing so, he beat Bud Kwiecinski of Clarkstown, 4-0. When Roefs lost in the semifinal round last year, Bud's brother, Al, was the one to do it.

The big upset came in the 106pound class when Bill Carron of Nanuet defeated Suffern's John Ackerson, 5-1. Ackerson has been top seeded although Carron reached the semifinal round in the 98-pound class last year.

Sid Buxton repeated in the 148pound class. The Nyack grappler bested Haverstraw's Dick Lou-

cas, 5-0.
