

Seeding

We will seed by <u>dual meet</u> record only. Have stats and records of each wrestler competing in the tournament with you. REMEMBER: DUAL MEET RECORD ONLY!

+½ point for each dual meet tie

*Do not add tournament wins or losses!

*We will seed all positive points and draw the negative points.

Scoring


We will not score a bracket unless there are six in the weight class.

Team scoring will be determined by the Official High School Wrestling Rules of the National Federation.

1st - 14 pts. +2 pts. - falls, forfeits, defaults, 2nd - 10 or disqualifications
3rd - 7 +1 pt. - superior decisions
4th - 4 +2 pts. - major decisions

+2 pts. - advancement in winners' bracket +1 pt. - advancement in losers' bracket

Here is an example of the bracket and how it is scored:



- The pigtail losers will be paired up to give them at least 2 matches in the tournament. They can only score pin points, etc. for the team.
- All consolation matches will be 1-2-2 in length.

General Information

There will be three mats used to speed things up. Two mats will be used for the consolations and finals.

There is only one restaurant in Pavilion, and it closes at noon. For this reason, we strongly encourage each team to use our wrestling club's refreshment stand.

Pavilion, NY, is located on the corner of Routes 63 and 19. The school is ½ mile up the hill on Route 63, south, and on the right. Park way in the back, past the bus garage.

Due to the big lack of locker space, I am requesting that coaches make sure that their wrestlers double or triple in one locker. Please provide your own lock and towel. We are not responsible for any lost items. Do not bring any valuables.

There will be coffee and donuts for coaches and officials in the morning.

Please call in your varsity line-up so I can have the programs made up. Please call as soon as possible.

All coaches are to act as supervisors. Please patrol your locker room to prevent any vandalism.

If your team wrestles the night before the tournament, please give me a call. We will all receive an extra pound.

Please plan on being at Pavilion early enough so that we can start on time. Plan for bad weather conditions.


