Weigh-Ins conducted with singlet on in the gymnasium. \*\* NO SATELLITE WEIGH-INS ALLOWED \*\*

YOU MUST WEIGH-IN THE MORNING OF COMPETITION TO ENSURE WE HAVE EVERYONE IN ATTENDANCE AT THE EVENT. WE WILL USE THE MADISON SYSTEM TO CREATE BRACKETS.

Cost: \$40.00. Payment Includes registration for BOTH styles. (Walk-Ins Only, No Pre-Registration).

Ideally each wrestler will have 6 matches total: 3 Greco-Roman, & 3 Freestyle matches.

You may choose to compete in Freestyle ONLY, but the cost remains the same.

<u>Format</u>: <u>4-Man Round Robin</u>. You will need to fill out two separate registration forms.

One registration for *Greco-Roman*, and one registration for *Freestyle*. Period Length will be two, 2 minute periods (2-2) for 8U, 10U, 12U, 14U, & 16U.

Period Length will be two, 3 minute periods (3 - 3) for Juniors.

Wrestling Begins: 9:30 am

• Greco-Roman will be first, and will begin as soon as brackets are ready.

• Freestyle will start as soon as Greco is completed, and when brackets are ready.

Awards: Ribbons for Champions.

Concessions: There will be a full concessions stand available throughout the tournament.
