Rules: NYS High School Rules. 3-1 minute periods (1 min then 30 second SD)
11/12 & 13/14 year olds will wrestle 3 - 1½ minute rounds

Admission: \$15.00 per wrestler

Eligibility: Participants must be between the ages of 5-14. Ages will be determined as of 3/24/2007. Wrestlers must have birth certificate if challenged. Wrestlers Limited to one entry.
