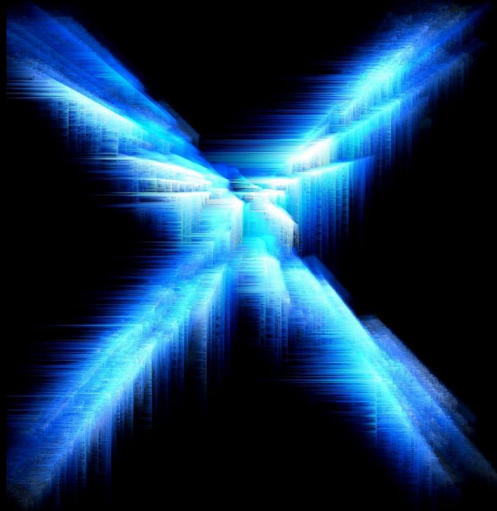

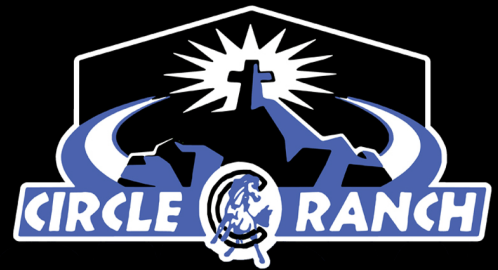

RELEASE AND ACKNOWLEDGEMENT OF RISK  
For All Activities on Camp Property**

1. I expressly agree and promise to accept and assume all the risks existing in this Lasertron/and or climbing wall/and or horseback riding activity. My participation in this activity is purely voluntary, and I elect to participate in spite of risks.
2. I hereby voluntarily release, forever discharge, agree to indemnify and hold Circle C Ranch harmless from any and all claims, demands, or causes of action, which are in anyway connected with my participation in this activity or my use of Circle C Ranch equipment or facilities, including any such Claims which allege negligent acts or omissions of Circle C Ranch.
3. Should Circle C Ranch or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
4. **I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else, I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical condition, which could interfere with my safety in this activity, or else, I am willing to assume – and bear the costs of – all risks that may be created, directly or indirectly, by any such condition.**

In the event that I file a lawsuit against Circle C Ranch, I agree to do so solely in the state of New York, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
